

June 2019 is a Seller's market! The number of for sale listings was down 6.6% from one year earlier and up 5.4% from the previous month. The number of sold listings increased 4.8% year over year and increased 1.9% month over month. The number of under contract listings was down 28.7% compared to previous month and down 17.1% compared to previous year. The Months of Inventory based on Closed Sales is 1.4, down 12.5% from the previous year.

The Average Sold Price per Square Footage was up 2.6% compared to previous month and up 5.3% compared to last year. The Median Sold Price decreased by 1% from last month. The Average Sold Price also decreased by 1.6% from last month. Based on the 6 month trend, the Average Sold Price trend is "Neutral" and the Median Sold Price trend is "Neutral".

The Average Days on Market showed a downward trend, an increase of 14.3% compared to previous year. The ratio of Sold Price vs. Original List Price is 99%, was the same compared to previous year.



#### It is a Seller's Market

#### **Property Sales (Sold)**

June property sales were 109, up **4.8%** from 104 in June of 2018 and **1.9%** higher than the 107 sales last month.

### **Current Inventory (For Sale)**

Versus last year, the total number of properties available this month is lower by 11 units of 6.6%. This year's smaller inventory means that buyers who waited to buy may have smaller selection to choose from. The number of current inventory is up 5.4% compared to the previous month.

### **Property Under Contract (Pended)**

There was a decrease of **28.7%** in the pended properties in June, with 87 properties versus 122 last month. This month's pended property sales were **17.1%** lower than at this time last year.





## The Average Sold Price per Square Footage is Appreciating\*

The Average Sold Price per Square Footage is a great indicator for the direction of property values. Since Median Sold Price and Average Sold Price can be impacted by the 'mix' of high or low end properties in the market, the Average Sold Price per Square Footage is a more normalized indicator on the direction of property values. The June 2019 Average Sold Price per Square Footage of \$238 was up 2.6% from \$232 last month and up 5.3% from \$226 in June of last year.





## The Days on Market Shows Downward Trend\*

The average Days on Market (DOM) shows how many days the average property is on the market before it sells. An upward trend in DOM trends to indicate a move towards more of a Buyer's market, a downward trend indicates a move towards more of a Seller's market. The DOM for June 2019 was 24, the same as last month and up 14.3% from 21 days in June of last year.

### The Sold/Original List Price Ratio is Rising\*\*

The Sold Price vs. Original List Price reveals the average amount that sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. This month Sold Price vs. Original List Price of 99% is the same as last month and the same as in June of last year.

## The Average For Sale Price is Neutral\*


The Average For Sale Price in June was \$626,000, up *6.8%* from \$586,000 in June of 2018 and down *1.6%* from \$636,000 last month.


#### The Average Sold Price is Neutral\*

The Average Sold Price in June was \$545,000, up **2.8%** from \$530,000 in June of 2018 and down **1.6%** from \$554,000 last month.

#### The Median Sold Price is Neutral\*

The Median Sold Price in June was \$515,000, down 0.8% from \$519,000 in June of 2018 and down 1% from \$520,000 last month.





### It is a Seller's Market\*

A comparatively lower Months of Inventory is more beneficial for sellers while a higher months of inventory is better for buyers.

\*Buyer's market: more than 6 months of inventory Seller's market: less than 3 months of inventory Neutral market: 3 – 6 months of inventory

### Months of Inventory based on Closed Sales

The June 2019 Months of Inventory based on Closed Sales of 1.4 was decreased by 12.5% compared to last year and the same compared to last month. June 2019 is Seller's market.

### Months of Inventory based on Pended Sales

The June 2019 Months of Inventory based on Pended Sales of 1.8 was increased by 12.6% compared to last year and up 49.5% compared to last month. June 2019 is Seller's market.

## It is a Seller's Market\*

Absorption Rate measures the inverse of Months of Inventory and represents how much of the current active listings (as a percentage) are being absorbed each month.

\*Buyer's market: 16.67% and below Seller's market: 33.33% and above Neutral market: 16.67% - 33.33%

### **Absorption Rate based on Closed Sales**

The June 2019 Absorption Rate based on Closed Sales of 69.9 was increased by 12.2% compared to last year and down 3.3% compared to last month.

### **Absorption Rate based on Pended Sales**

The June 2019 Absorption Rate based on Pended Sales of 55.8 was decreased by 11.3% compared to last year and down 32.3% compared to last month.
